- 5. I promise never to use the computer to be hurtful to others. I will not view, send or display inappropriate messages or pictures.**
- 6. I promise to print only when my teacher tells me to.**
- 7. I promise to only use my own files or folders on the computer.**
- 8. I promise to talk to my parent/guardian about what kind of web sites I am allowed to look at and I will only look at information I know my parent/guardian would say is “ok”.**

I understand that if I break my promises, I might not be able to use the computers.
